- Advocate to implement policy and environmental changes related to physical activity, nutrition, and tobacco and collaborate on related programs in the county that assure access to mandated and essential public health services.
- ♦ Market and implement the Infant Mortality Reduction Programs.
- **♦** Establish and convene a workforce development/work relation committee.
- ♦ Maintain fiscal management of agency, including Home Health.

FY16-17 Accomplishments and Highlights

- Grand Re-Opening of the Clinic and Home Health buildings after sustaining severe damage due to the effects of Hurricane Matthew.
- Ryan White Program Accomplishments: The Ryan White Part B
 Grant was refunded. The Prevention with Positive Grant was
 awarded. Tommy Jones (CLEAR/MRI Coordinator) received two
 state awards (NC Long Term Survivors Award and ART Jackson Client Voice Advocate Award).
- The Agency's chronic disease program celebrated World AIDS Day at the Gallery Theatre in Ahoskie with an Art Exhibition & Educational Symposium.
- The Care Coordination For Children Program signed on a total of 176 new clients in FY 16-17.
- ♦ The Hertford County Public Health Authority in collaboration with Vidant Roanoke-Chowan Hospital, Vidant Pitt Hospital and Hertford Health Maintenance Alliance merged resources to develop the 2016 Community Health Needs Assessment.
- Personal Health Services received grant funds to implement the Safe Sleep Training Program to qualified residents of Hertford County.
- Personal Health Services received grant funds from Vidant Roanoke Chowan Hospital, Community Benefits Grant for \$20,000 to support the Breast and Cervical Cancer Prevention Program (BCCCP).
